Introduction



The Officers of the European Renal Association (ERA), together with the entire ERA Council are honoured to present this report on the activities of our Society of the year 2023. We are very pleased to confirm that during the last year many new initiatives started in particular a special collaboration between ERA and the National Societies of Nephrology that allowed our Society to reach an unprecedented number of active members. The financial statements were also successful confirming the period of growth of our Society.

At the beginning of 2023 the new National Society Membership Project became a reality: 31 National Societies joined the project allowing ERA to reach over 20.000 members in 2023. The project is so successful that the number of EU countries joining is growing and ERA is also receiving request from outside of Europe (South America, India, etc.).

In March 2023, under the umbrella of EKHA (European Kidney Health Alliance), of which ERA is a founding member, a special “Show your kidneys love” campaign featuring Tina Turner was launched with the aim of creating a very much needed awareness on kidney disease among the general public, in particular for prevention purposes.

In 2023 ERA celebrated its 60th anniversary and the Congress in Milan (Italy) was an excellent opportunity to celebrate this important date. The Congress was a great success and a similar number of delegates decided to participate, a number as we had pre-Covid 19: we had over 9,400 participants (8,000 in person and 1,400 virtually connected). The networking component was even more enhanced by a number of new

initiatives that were very much appreciated by our members.

For the first time during our annual Congress, we organized “Learn by practice” sessions offering a wide range of very practical tips for the younger generation of specialists (i.e. how to prepare a medical presentation, how to manage family and career, how to set up a clinical trial, etc.). This novelty was very much appreciated, and it will be featured also in the future.

The launch of the ERA Neph-Manual (an educational online manual which is an ERA membership benefit) was done during the annual Congress.

At the General Assembly at the annual Congress the first women President was nominated as President Elect: Prof. Roser Torra (Barcelona, Spain) will officially take office at the time of the 2024 General Assembly.

The important EU Funded project, N-Path, which focuses on training in interventional nephrology presented its final outcome during the ERA annual Congress.

Sustainability is extremely important. ERA has launched a campaign to make sure that this is taken very seriously in all its activities, annual Congress included. An important article was recently published specifically taking into consideration the [2023 ERA Congress](#).

Last, but not least, during the Congress ERA gave a complimentary congress membership to all Turkish and Ukrainian nephrologists: this decision was taken by the ERA Council following the catastrophic earthquake in Turkey as well as the horrific ongoing conflict in Ukraine,

thus allowing all our members living and working in these countries to fully attend the Congress (which is hybrid).

2023 was also the year in which the restructuring of the ERA Headquarters in Parma was finalized. Since then the office hosted a number of very successful full day board meetings of all ERA bodies, including the ERA Council, thus making full use of the new structure which has been called the “ERA Headquarters and Educational Hub”.

The Ukrainian Renal Disaster Relief Task Force (RDRTF), which was created at the beginning of 2022, was transformed into a permanent task force with a new name (Kidney Relief in Disasters). This task force will focus on all disasters (man-made and natural) and also provide education on preparedness, in particular with the National Societies of Nephrology. In 2023 this task force supported members and thus also patients in the Earthquake in Turkey (6/2/23), the civil war in Sudan (with ASN – American Society of Nephrology and ISN – International Society of Nephrology a joint statement in support to the population subject to any type of disaster was issued – 19/5/23), the floods in Morocco and, finally, the ongoing Gaza-Israel conflict.

Furthermore, on this very important topic, at the end of December 2023 at a leadership meeting with ASN and ISN, it was decided to join forces in this area to synergize the three Soc. efforts in this very important area and a very strong declaration against all man-made disasters was issued at the end of the year.

Networking and collaboration with other Societies is key for ERA and in

2023 ERA collaborated with two patient associations (EKPF – European Kidney Patient Federation and PKD International Polycystic Kidney Disease International) to create patient section on the ERA website, furthermore, another outcome of the collaboration with EKPF was an important document in Chinese to create awareness on kidney disease among the Chinese communities present in Europe.

CKJ’s (Clinical Kidney Journal) Editor in Chief was nominated in 2023, Prof. J. Floege (Germany) and he will officially take office during the General Assembly in 2024.

Two new task forces were established in 2023: Sustainable Nephrology and Strong Kidneys, the first one will focus on green practices in the field of nephrology and sustainability issues in all ERA’s activities, the second one instead will focus more on public health issues and awareness campaigns.

A call for another task force was done in 2023 (the task force will be created in 2024) called WERA = Women of ERA. One of the objectives of this task force will be to make sure that all ERA activities reach gender balance, as well as promote educational activities in this field.

Public affairs is also a field that is becoming more and more relevant, for this purpose the ERA Council decided to recruit an independent consultant in PA based in Brussels, his activities will be allow ERA to be even more effective in its contribution as a member both to EKHA as well as the Biomedical Alliance in Europe.

The members of this Council must stress that current achievements are built on the accomplishments of previous officers and Council members, without whom it would not be possible to stand where we are right now. We will strive to continue their good work and continue to promote important initiatives for the nephrology society.

Finally, we are delighted to welcome you to Stockholm (Sweden) for the next ERA Congress where we will again meet at our annual Congress to network but also to listen to the best science, exchange and learn from each other! The Congress is planned to take up a hybrid form, both live in Stockholm and virtually, from May 23-26, 2024.

CMEs organised by ERA Working Groups and Bodies

Some ERA Working Groups and Bodies organised thematic educational courses.

All CMEs have been accredited by the European Accreditation Council for Continuing Medical Education (EACCME®) and attendees received diplomas granting European CME credits (ECMEC®s).

On January 19-21, 2023, the European Renal Osteodystrophy (EUROD) Registry, an initiative of the CKD-MBD Working Group, organised the **"6th European Renal Osteodystrophy (EUROD) Winter Meeting"** that was held in Leuven (Belgium) and virtually.

On May 6-7, 2023, the Immunonephrology Working Group (IWG) organised the CME Course **"Advances in Glomerular Disease"** in collaboration with the Mayo Clinic and the Turkish Society of Nephrology.

The event was held in Istanbul (Türkiye) and virtually.

The traditional ERA Registry's **"Introductory Course on Epidemiology"**, which aims to teach nephrologists, paediatric nephrologists, and nephrology researchers the basic principles of epidemiology, was organized on May 24-25, 2023 in Prague (Czech Republic).

Young Nephrologists' Platform (YNP) Annual Report



In 2023, the Chair of YNP was Orsolya Cseprekál and Safak Mirioglu was Chair-Elect. Amaryllis Van Craenenbroeck (Belgium) Amaryllis Van Craenenbroeck (Belgium) finished her term as Chair becoming the Past-Chair.

At the 2023 ERA Congress, 2 board members ended their term: Andreas Kronbichler (Austria) and Ewa Pawłowicz (Poland) left the YNP Board. Instead, the following 3 members joined the board: Fernando Caravaca-Fontán (Spain), Balazs Odler (Austria) and, Elisabet Van Loon (Belgium). Until December 2023 YNP had approximately 5454 members.

Initiatives

- *National Representatives:* in 2023, YNP had 26 national representatives. The aim of this group is to represent YNP at National level connecting YNP to young national nephrologists and promoting all YNP initiatives also through engagement in YNP social media. The full list of YNP Representatives can be found [here](#).
- *Free Membership:* for the abstract-based track, in 2023, YNP allotted all the Congress based free memberships (30 best abstracts submitted by YNP Members for the 2023 ERA Congress). The list of the 30 YNP members can be found here. For the Publication-based track, in 2023, YNP receive 14 applications for the publication based free memberships, 72% (n=10) received the benefit, 21% (n=3) were not YNP members and thus could not apply, 7% (n=1)

did not fulfil the requirements (article not accepted for publication). More information [here](#).

- *Mentorship Programme:* the 2023 version of the program had [23 mentors](#) (13 mentors from previous years who agreed to continue, plus 10 new mentors who joined in 2023). At the end of November 2023, after the open call for mentees, 18 applications were received.
- *YNP Speaker Database:* this initiative aims to gather active ERA YNP members who are highly qualified as young speakers and who will be proposed for international meetings, including the ERA Congresses, CME courses, joint meeting between YNP and other Societies. As of December 2023, the speaker database had 36 YNP active members. 2 members of the database were automatically transferred to the main ERA speaker database as they were no longer YNP members.
Collaboration with other societies:
 - ▶ JSN: in 2023, the nominated YNP representative for the JSN Congress was Rebecca Herzog. For the 2023 ERA Congress, the JSN representative was Sho Hasegawa. e-seminar: In March 25, the first joint e-seminar between YNP (ERA) and YPNP (ESPN) was organized as an initiative for the young professionals. The meeting had 97 attendees from 45 countries.
 - ▶ ESPN: Christoph Kuppe was nominated as the YNP representative

for the ESPN Congress. For the 2023 ERA Congress the ESPN representative was Anne Mühlig.

► KSN: In 2023, the nominated YNP representative for the KSN Congress was Francesco Trepiccione. For the ERA 2023 Congress, Jeong-Hoon Lim and Kim Hyounghae were invited as representatives of the KSN.

► Joint e-seminars:

- On March 24, the second joint e-seminar between YNP (ERA) and JSN (Japanese Society of Nephrology) was held. The meeting had 82 attendees from 17 countries.
- The second joint e-seminar between YNP (ERA) and YPNP (ESPN's young experts) was held on September 25. There were 176 participants from 66 countries.
- On November 21 a collaborative e-seminar between the G&K ERA Working Group and YNP was held. The e-seminar had a YNP member as a guest speaker. There were 193 participants from 61 countries.

- ERA National Society of Nephrology Grant. During 2023, this grant was given to the following YNP members: Tiago Pinto Coelho (Belgium), Karoline Rosenkranz (Germany), Izabela Szubert (Poland), Sonya Gussaova (Russia), Luis Loureiro-Harrison (Scotland), Karol

Graňák (Slovak Republic), Leire Munoz Hernando (Spain); Anna Rinaldo (Switzerland), Zeynep Ural (Türkiye). This grant, the winner of which is selected directly by the National Societies of Nephrology, includes a free ERA Congress registration and three years of free ERA membership as well as a special diploma prepared by ERA that is delivered to the winner during the National Society meeting.

- *Collaboration with NDT & CKJ:* during 2023 there was an active collaboration between YNP and the ERA official journals.

► **Launch of the new CKJ section: In Context – in collaboration with YNP:** after a lot of hard work between the YNP Board members, the CKJ Editor-in-Chief and the Editorial Office Manager, the new section '[In Context](#)' was presented to the CKJ readers. The introduction to the "In Context" section can be found here. In 2023, 7 articles were published, with 10 YNP members participating as authors (access to the articles [here](#)).

► **Reviewing NDT and CKJ articles as a YNP member:** active YNP members are invited to experience reviewing articles for NDT and CKJ. The YNP reviewers are all in ManuscriptCentral and highlighted with a green flag, so that the journals' Editorial Board Members can easily identify them. As of December 2023, 44 YNP members were participating in this initiative.

► **Involvement of YNP members in The ERA Neph-Manual Nephrology Unfolded!** 15 YNP members were actively involved as authors or co-authors in this new ERA initiative that aims to promote medical expertise by combining the presentation of interesting case examples with a discussion of pathophysiological mechanisms and therapeutic principles.

► **10th anniversary of the YNP:** in 2023, in order to highlight and celebrate the 10th anniversary of the ERA YNP, an editorial article was submitted (in January 2024) to the CKJ by the Chairs of the YNP and its founder Prof. Andrzej Więcek.

► To further celebrate the 10th anniversary of YNP during the 2023 ERA Congress in Milan a special edition of the traditional **"Meet & Greet"** initiative took place. The meeting counted with the participation of 129 members.

Clinical Kidney Journal (CKJ)

[Clinical Kidney Journal \(CKJ\)](#) is one of the official publications of the ERA published by Oxford University Press. It is a fully open access, online only journal publishing monthly since 2021. The journal is an essential educational and training resource integrating clinical, translational and educational research into clinical practice. The Ad Interim CKJ Editor-in-Chief was Professor Mario Cozzolino, Milan, Italy, until September 2023, when the CKJ Editor-in-Chief Elect, Professor Jürgen Floege, Aachen, Germany took over. His official term as the new CKJ Editor-in-Chief will start after the 2024 General Assembly which will take place during the 61st ERA Congress (May 23-26, 2024, Stockholm, Sweden).

The [Editorial Board](#) consists of 6 Associate Editors, 2 Statistical Advisors, 4 Social Media Editors, and over 40 internationally renowned experts in nephrology.

CKJ received 1.718 submissions (1.314 original and 404 revised) in 2023. The overall acceptance rate was 18.6%. All submissions to CKJ have undergone peer review. CKJ publishes editorials, reviews, original articles, pro/con debates, exceptional cases, and letters to the editor. In 2023 CKJ also launched several new manuscript types in the journal:

- 'In Context' in collaboration with the ERA Young Nephrologists' Platform in which key publications in the field of nephrology are explained from a clinical point of view.
- A series on 'The Forgotten Sex – Gender Disparities in Kidney Disease' exploring gender bias, why it occurs, how it manifests, its impact and potential solutions in the setting of kidney disease.

- A series on 'Epidemiology and Biostatistics in Medicine' in collaboration with the ERA Registry.

All graphical abstracts and figures are redesigned by a professional medical illustrator before publication.

In 2023, the journal received 1.359.210 full-text downloads. The impact factor is 4.6, ranking the journal 17/88 in the nephrology/urology category.

In 2023, CKJ published the accepted, unedited manuscripts online within 3 to 5 working days after the author license had been signed. The accepted manuscript was then replaced by the final, typeset proof within 6 weeks. The average review process took 2 to 3 weeks.

Clinical Kidney Journal (CKJ)

Each online *CKJ* publication shows its individual Altimetrics score which is the amount of attention the article has received online, in social media, and from news sites. The highest Altimetrics scoring paper in 2023 was: '[Kidney function changes in acute heart failure: a practical approach to interpretation and management](#)'.

CKJ is widely promoted on social media. The CKJ X account (@CKJsocial) reached over 12.000 followers in 2023 and the ERA SoMe team launched reels on *CKJ* publications on the ERA Instagram account. At the end of 2023, the journal also launched its own monthly Newsletter in which highlights of each new *CKJ* issue, important news, etc. are promoted.

In 2023, the ERA Journal Club continued. Each month, a high-impact article was discussed in a webinar with the authors and external panelists. During these webinars, the audience could also ask live questions to the speakers. The Journal Club archive can be accessed [here](#).

In 2023, *CKJ* published a successful joint collection with Nutrition Reviews including articles from NDT, *CKJ* and Nutrition Reviews on the important link between nutrition and kidney health.

The [2023 reviewers](#) of the journal are also acknowledged on the *CKJ* homepage and ERA platform and the top 3 reviewers, Drs Putra Bobby Pratama, Kaitlin Mayne, and Safak Mirioglu received an official certificate at the annual Editorial Board meeting. Members of the ERA Young Nephrologists' Platform also again showed great interest in reviewing for *CKJ* which is the result of the [journal's reviewer mentorship program](#).





ERA Neph-Manual



In 2023, the ERA launched the [ERA Neph-Manual](#). This Manual, presented as an e-book on the ERA platform, is specifically designed for young nephrologists and is meant to support their training in and broaden their knowledge of the nephrology specialty.

Access to the ERA Neph-Manual is an exclusive ERA membership benefit. The Manual is published by the ERA thanks to the support of the [European Renal Association Curatorium \(ERAC\)](#).

After an open call, Professor Jeroen Kooman (Maastricht, The Netherlands) was elected as the Editor-in-Chief. The [Editorial Board](#), responsible for evaluating the quality of each chapter, consists of 15 members of the ERA Young Nephrologist's Platform and 40 senior experts in the field.

The ERA Neph-Manual has the following ISBN number:



The Manual consists of different chapters covering various aspects of kidney disease and discusses pathophysiology, clinical presentation, diagnosis, and treatment in clearly subdivided blocks, accompanied by graphical abstracts, and several tables and illustrations. Each chapter consists of interesting case examples and ends with 'test yourself' and multiple-choice questions. All graphical abstracts and figures are redesigned by a professional medical illustrator before publication.

The chapters are all written by experts in the field together with young nephrologists as co-authors. To give full visibility to the authors, there is a 'Meet the Authors' part in each chapter with a short bio and portrait photo of each author.

There will be regular updates of the already published chapters according to further advancements in the field.

During the 60th ERA Congress, two advisory board members ended their terms (Mario Cozzolino as Chair and Kitty Jager as Board Member).

2. Learn by practice on Hyperkalemia in CKD: chaired by Pantelis Sarafidis with Andrea Galassi and Kieran McCafferty as speakers.

- Guideline on use of Antimicrobial - Antimicrobial Dosing in patients with special conditions – Renal impairment: ERA – ERBP was invited by the European Society of Clinical Microbiology and Infectious Diseases (ESCMID) to participate in the development of this guideline.
- Global Alliance for Living Evidence (GALE): Proposal from a non-profit alliance/company to make changes in guideline development with a living guideline process.

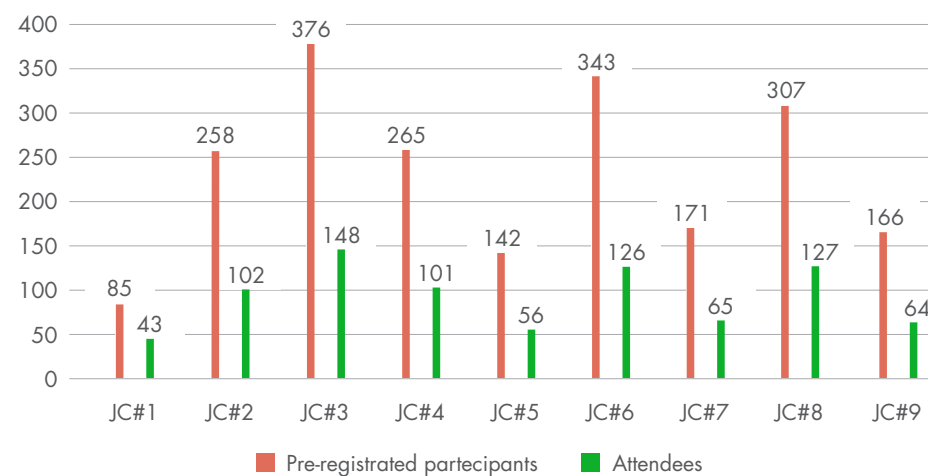
Supported with Unrestricted Grants

ERA Journal Club: 9 journal clubs were held between January and November. The total number of pre-registered attendees was 2113 from 131 countries, while the number of unique attendees was 832 from 98 countries.

A graphical view of each journal club is shown in the chart below. The average attendance rate was 39%.

e-seminars

Other Series: during 2023, there were ongoing 6 series supported with unrestricted educational grants.

- **Optimising care and managing complications for the CKD patient (CKD patient series):** series of 6 webinars, with the #1 held in November 2021 while the #2, #3 and #4 were held in 2022. In 2023, the last two webinars of the series were held:
 - ▶ #5 CKD Progression: interpreting guidelines through the lens of recent data CKD and RAASi optimisation (February 16): had 157 attendees from 51 countries.
 - ▶ #6 Implementing a programme of RAASi optimisation for patients with CKD and HF (April 13): had 121 attendees from 58 countries.

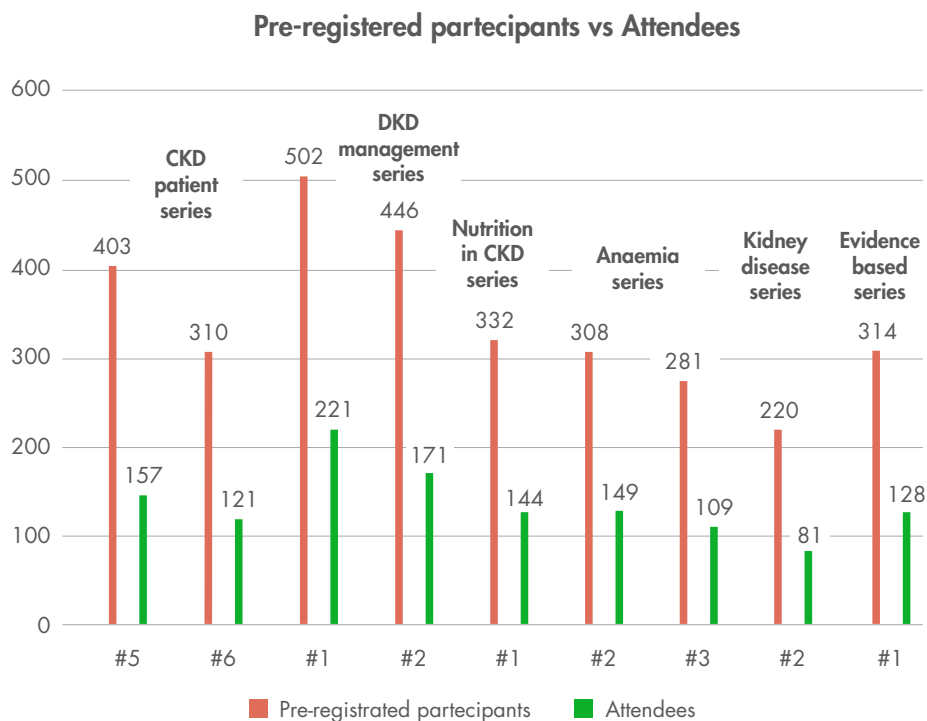

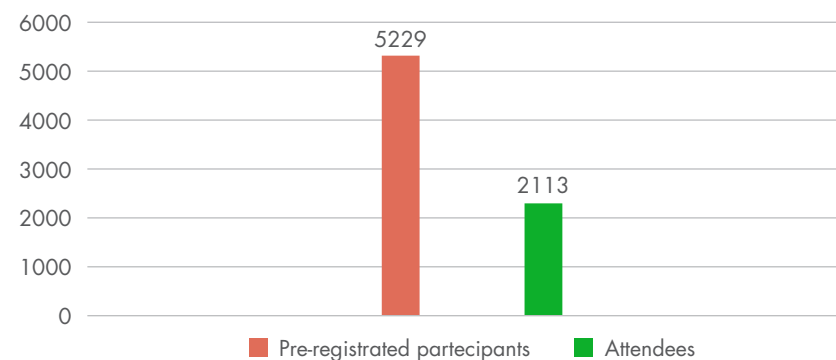

The graphic below shows the pre-registrants vs the attendees to each webinar.



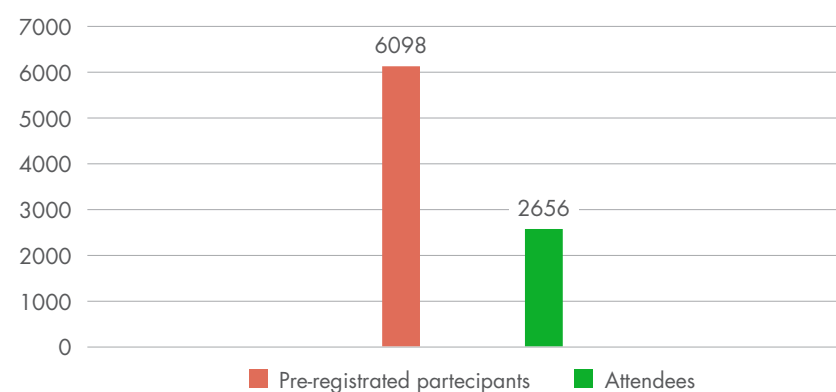
Type 1 (Supported with Unrestricted Grants):

Type 2: Pre-registered participants vs Attendees



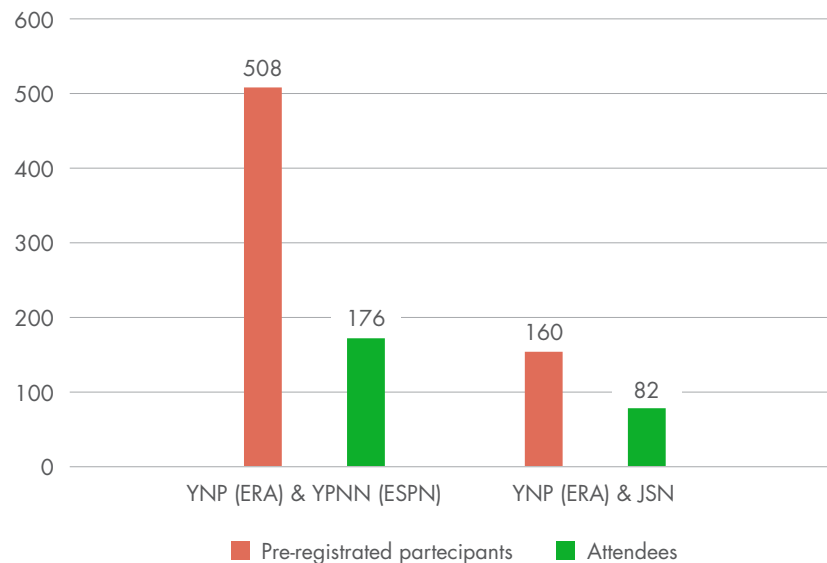

Pre-registered participants vs Attendees

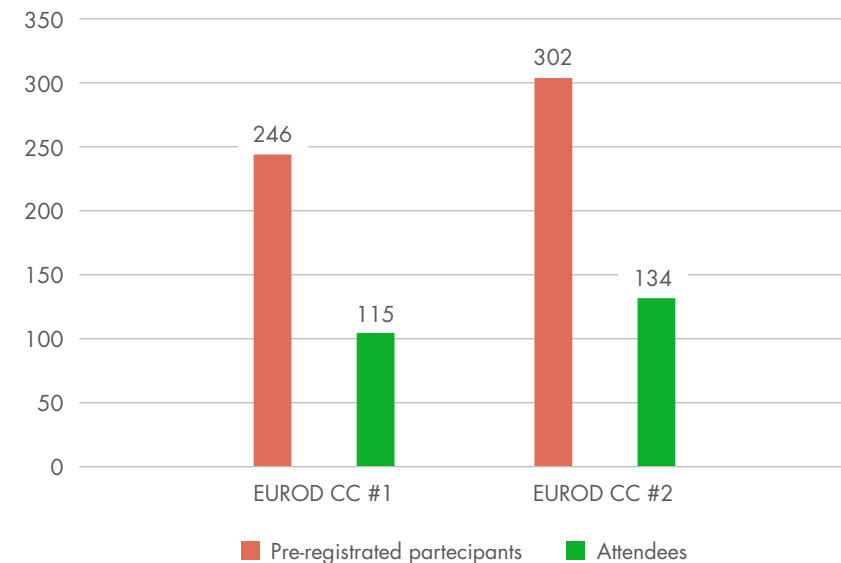


EUROD Case Conferences

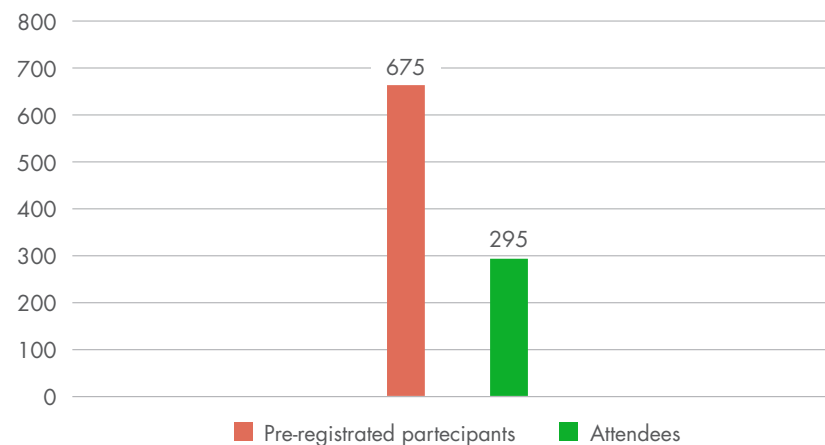

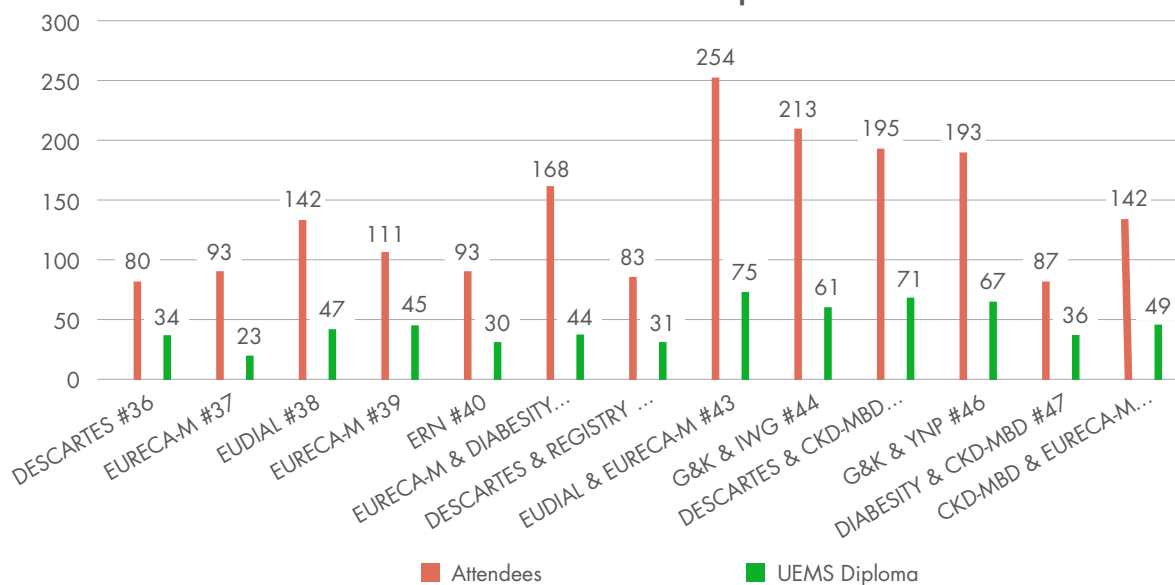

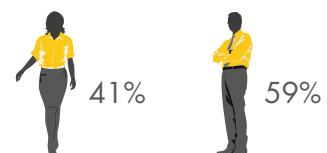

ERAKI is the new ERA Working Group launched in 2023.

Since its establishment, the Board has worked very hard to integrate the topic of Acute Kidney Injury (AKI) into the educational and research activities of the ERA.





Nephrology Dialysis Transplantation (NDT)



[*Nephrology Dialysis Transplantation \(NDT\)*](#): an international basic science and clinical renal journal is one of the official journals of the ERA published by Oxford University Press. The new NDT Editor-in-Chief is Professor Hans-Joachim Anders from Munich, Germany, who took over the journal from Professor Denis Fouque, Lyon, France whose 6-year term ended after the 2023 ERA Congress (June 15-18, 2023, Milan, Italy).

NDT is a hybrid journal and is the leading nephrology journal in Europe as well as being renowned worldwide, devoted to original clinical and laboratory research in nephrology, dialysis and transplantation.

The [Editorial Board](#) consists of 8 Associate Editors with 8 Editorial Fellows, 4 Statistical Advisors, a Kidney Art and YouTube Editor, 2 Journal Club Editors, 3 Graphical Abstracts Editors, 6 Social Media Editors and over 80 internationally renowned experts in nephrology.

The 8 Editorial Fellows were selected after a 'Call for Editorial Fellows'. The Editor-in-Chief launched this Editorial Fellowship program to broaden the spectrum of expertise of the Editorial Board and to offer a learning opportunity in the process of medical publishing. Editorial Fellows work hand-in-hand with one of the Associate Editors and are involved in all aspects of the editorial process.

The new Editor-in-Chief also installed weekly Editorial Board meetings with the Associate Editors and Editorial Fellows during which evaluations of certain NDT papers are intensively discussed before sending the decision letters to the authors.

NDT publishes original articles, special reports, invited reviews, editorials, treatment/diagnostic standards, and research letters. All publications in NDT have undergone peer review. All graphical abstracts and figures are redesigned by a professional medical illustrator before publication.

The new NDT Editor-in-Chief has changed the lay-out of the journal and the cover images are now chosen by the NDT Editorial Board members following a '[Call for Cover Images](#)'. All image submissions are published in the [NDT Kidney Art Gallery](#) and the images that are selected for the covers of the journal are also archived in this [NDT cover archive](#).

NDT received 2.042 submissions (1.681 original and 361 revised) in 2023. The final 2023 acceptance rate was 13.3%. Articles published in NDT were downloaded 3.611.824 times in 2023. The journal's Impact Factor is 6.1, ranking NDT 10/88 in the nephrology/urology category and 4/26 in the transplantation category.

Nephrology Dialysis Transplantation (NDT)

NDT published the accepted, unedited manuscripts online within 3 working days after the author license had been signed. The accepted manuscript was then replaced by the final, typeset proof within 6 weeks. The average review process took 2 to 3 weeks.

The proportion of open access publications in NDT continued to rise in 2023 (37% in 2023 versus 31% in 2022).

Each online NDT publication shows its individual Altmetrics score which is the amount of attention the article has received online, in social media, and from news sites. The highest Altmetrics scoring paper in 2023 was: [The five types of glomerulonephritis classified by pathogenesis, activity and chronicity \(GN-AC\)](#).

NDT is widely promoted on social media. The NDT X account (@NDTsocial) reached over 15.000 followers in 2023 and the ERA SoMe team launched reels on NDT publications on the ERA Instagram account. At the end of 2023, the journal also launched its own monthly Newsletter in which highlights of each new NDT issue, videos, important news, etc. are promoted.

In 2023, the ERA Journal Club continued. Each month, a high-impact article was discussed in a webinar with the authors and external panelists. During these webinars, the audience could also ask live questions to the speakers. The Journal Club archive can be accessed [here](#). Each month an NDT article is also discussed on the YouTube channel MARKUS @ HOMe.

In 2023, NDT published a successful joint collection with Nutrition Reviews including articles from NDT, CKJ and Nutrition Reviews on the important link between nutrition and kidney health.

The [2023 reviewers](#) of the journal are acknowledged on the NDT homepage and ERA platform and the top 3 reviewers, Drs Francesco Locatelli, Nick Chesnaye, and Panagiotis I. Georgianos received an official certificate at the annual Editorial Board meeting. Members of the ERA Young Nephrologists' Platform also again showed great interest in reviewing for NDT which is the result of the [journal's reviewer mentorship program](#).





ERA Registry

The ERA Registry is a European Registry collecting data on kidney replacement therapy via the national and regional renal registries in Europe and in countries bordering Europe or the Mediterranean Sea. It analyses these data and distributes the resulting information through registry reports presented at the yearly ERA Congresses, publications in nephrology journals and through this website.

The ERA Registry is funded by the European Renal Association (ERA). Since June 2000, the Registry office is housed in the Department of Medical Informatics in the Amsterdam University Medical Centers (location AMC) in Amsterdam, The Netherlands. The Registry is part of an ISO 9001:2015 certified quality management system, and an ISO 27001:2013 certified information security management system. These certificates were provided by Lloyd's Register Quality Assurance.

Kidney Relief in Disasters Task Force (KRDTF)



Established in response to the emergency situation in Ukraine in 2022, the Kidney Relief in Disasters Task Force (KRDTF), formerly known as the Renal Disaster Relief Task Force (RDRTF), was created to address critical needs of kidney patients and healthcare providers in Ukraine after the invasion of Russia.

In 2023, the KRDTF continued its mission with unwavering commitment in Ukraine, but also in Sudan, in Morocco and, finally, in Gaza-Israel. During a face-to-face meeting at the 2023 Congress in Milan, the Task Force unanimously opted to rename itself as the Kidney Relief in Disasters Task Force (KRDTF), signifying a deeper commitment and a strategic shift towards a more inclusive approach in supporting global kidney health during disasters (man-made and natural) including also educational goals.

Task Forces

Kidney Relief in Disasters Task Force (KRDTF)

Key Accomplishments:

1. Strategic Development: As mentioned above, the Task Force rebranded itself as the Kidney Relief in Disasters Task Force, emphasizing a commitment to extending aid beyond Ukraine to include a wider range of natural and man-made disaster-affected regions within the ERA's geographical influence (Europe, countries bordering Europe and the Mediterranean Sea). Regulations were prepared, and approved by the ERA Council in November 2023, to regulate the duties and rotation of the task force members with set goals and objectives. A call for task force members was performed and it will become effective at the time of the ERA Congress in Stockholm (May 2024).
2. Collaborative Alliances: Strengthening partnerships with Direct Relief and the World Health Organization (WHO), the Task Force facilitated efficient coordination and delivery of aid to disaster-affected regions, significantly enhancing effectiveness and outreach.
3. Knowledge Sharing: Throughout the year, the Task Force contributed insightful publications to ERA via its journal NDT, sharing valuable best practices and insights in renal healthcare during disasters. Additionally, a session was conducted at the Milan ERA Congress 2023, fostering collaboration and knowledge exchange among nephrology professionals.

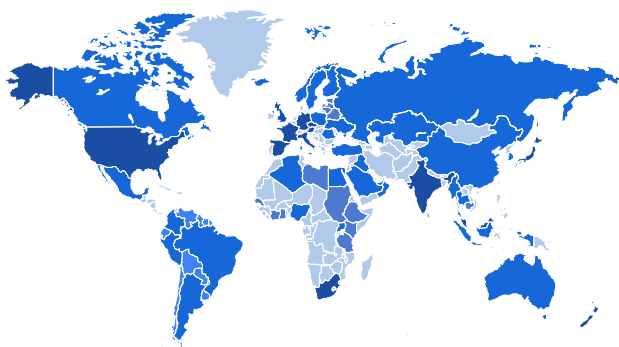

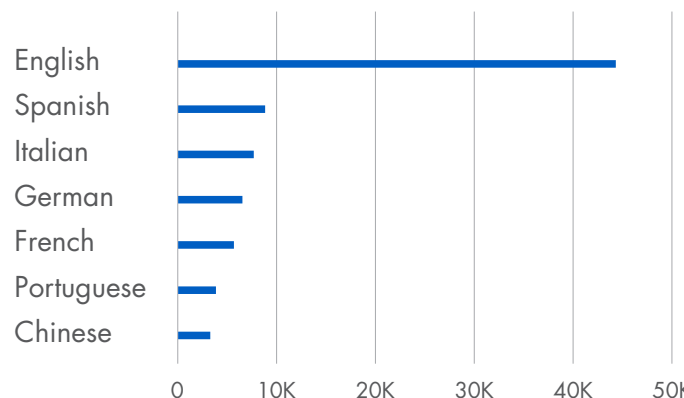

SOCIAL MEDIA

The ERA Community on social media increased considerably during the year*, especially on Instagram (+41.11%), YouTube (+29.55% subscribers) and X (+27,21%). SOCIAL MEDIA TEAM

In March 2023, ERA opened a call for the new Social Media Team Members to share knowledge, promote educational opportunities and offer complete coverage of the ERA's annual congress and e-seminar programme through tweetorials, interviews, polls, visual abstracts, reels, and Instagram stories. 20 Members from 9 countries were approved by the Council for the 2023 coverage of social media. A second open call has been opened in November 2023 for extra positions.

NEWSLETTERS

In 2023, ERA sent 235 newsletters registered with an average open rate of **24.88%***.

ERA distributed 40 **e-seminars Weekly updates** and 22 issues of its official newsletter, **Nephrology News Flash**, which covers all the main topics and news related to the ERA mission: science, education, networking, and institutional activities.

In addition, the Association sent out 6 **Flash Congress Editions** from January to June 2023 to give relevant information about the Congress topics (abstract submission, registrations, scientific programme, etc.).

Press & Media Relations

During the year, the **ERA Press Office** distributed news and press releases, especially with other Societies, to also enhance the ERA networking activities:

For the **60th ERA Congress**, consistent communication to the media was provided in the lead up to and during the Congress via the ERA Press Office.

Overall, 57 journalists registered to the Congress: over 25 of them attended on-site, representing 11 individual media outlets. Over 35 interviews were conducted by media on-site and over 250 requests were received in the ERA press inbox.

Press activities included the distribution of daily congress bulletins, a media kit for journalists and a supervised press room dedicated to interviews and media relations.

A special press kit was distributed on June 14-16, with press releases on a selection of late breaking clinical trials (and a particular focus on the CONVINC trial) which were presented to the media under embargo, ahead of the data presentations.

The media coverage included articles from national and international media, such as Medscape, Santor, NewsFarma, EuropaPress, Renal & Urology News.

Over 2,700 articles have been published during the key month of Congress activity

The collaboration with JSN is extremely successful and this includes a webinar series organized together with the Young representatives of both societies as well as a series of meetings organized between the leaderships of JSN and ERA throughout 2023 to organize a joint meeting on *Kidney Health in Aging and Aged Societies* to be held in September of 2024 in Japan.

Webinar series are also organized between the young representative of ESPN and the ERA and between ESOT (EKITA) and two of ERA's Working Groups (DESCaRTES and EuDial) as well as Turkish Society of Nephrology and IWG.

ERA also continues its excellent collaboration with ASN (American Society of Nephrology) and ISN (International Society of Nephrology) and their joint initiatives. A full day retreat was held in Washington DC (USA) in December 2023.





Collaboration with Other Societies

An important joint statement regarding one of the joint projects was issued at the end of 2023, announcing the societies' new plan to coordinate their efforts toward helping people with kidney diseases and their caregivers (including nephrologists) during natural disasters and human conflicts throughout the world.

Another joint activity is linked to the dissemination of an important article (to be published in 2024), also the result of a joint project, underlining how CKD is a public health threat which urgently needs attention.

A third project will instead focus on how the specialty of nephrology has evolved in recent years and what are the threats towards the specialty, but also underlining the wide range of opportunities and the clinical excellence that this field offers.

EKHA

EKHA is an alliance of four societies created in 2007 to focus the attention of the political community and, through the media, of people at large, on the burden of Chronic Kidney Disease (CKD) considering patients' morbidity/mortality as well as the socio-economic impact of dialysis and transplantation in Europe: besides the ERA, the European Kidney Patients' Federation (EKPF, former CEAPIR), the European Dialysis and Transplant Nurses' Association/European Renal Care Association (EDTNA/ERCA) and Dutch Kidney Foundation (DKF) are EKHA management committee members. The EKHA management committee, which includes two representatives of ERA nominated by the Council, works closely with the people involved in the European health organization to raise awareness about CKD throughout Europe.

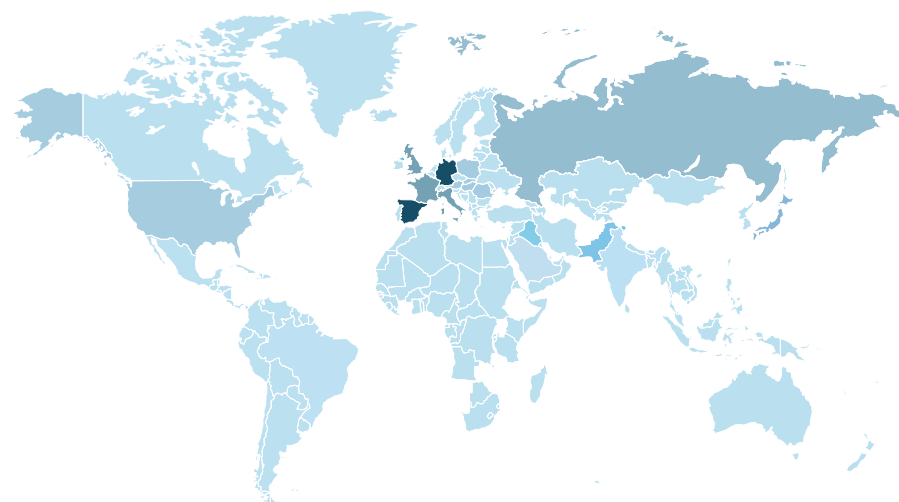

Members World Map - as of December 31, 2023



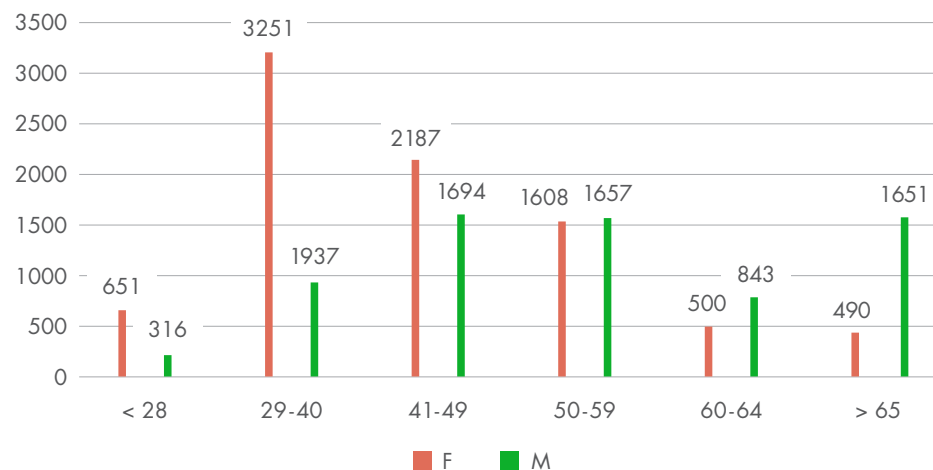

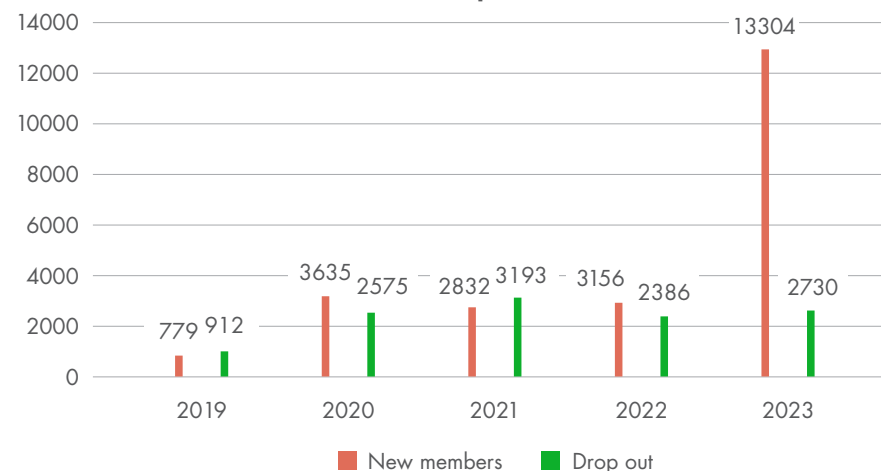
Members by age and gender - as of December 31, 2023*

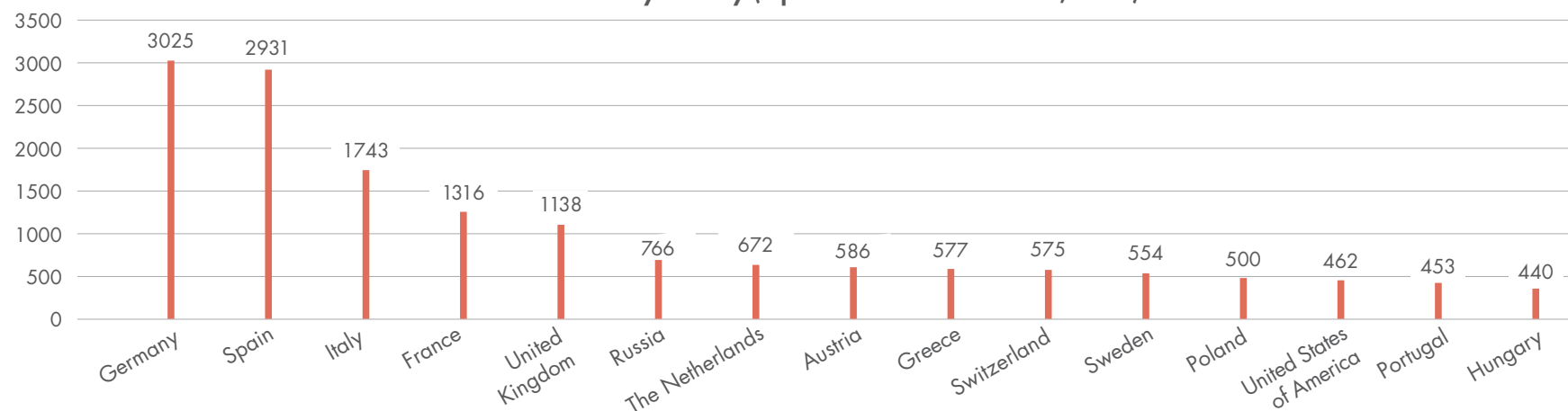
The following chart illustrates an overview of the drop-out vs. new member fluctuations in all countries from 2019 until 2023.

ERA Curatorium (ERAC)

The ERA Curatorium (ERAC) is a platform where members of the industry (supporting members) and members of the ERA Council sit together to bring forward diverse initiatives. The aim is to have an open and balanced discussion between ERA bodies and supporting members to find out common themes and to build a bridge between industry and academia in a broader sense of the nephrology.

In 2023, seven members from the ERA worked counterbalanced by seven supporting members from (in alphabetic order) AstraZeneca, Bayer, Boehringer Ingelheim, CSL Vifor, Fresenius Medical Care, GlaxoSmithKline, and Novartis.

During the ERA 2023 Congress in Milan, the second General Assembly was held as well as the ERA Symposium titled: CKD diagnosis and management in the primary care setting, with around 130 live participants. The Symposium was chaired by Alexander Rosenkranz and Jaquie Finn with Naresh Kanumilli, Daniel Gallego and Kieran McCafferty as panel members.

Additionally, two face-to-face meetings were held among the ERAC supporting members and ERA HQ.

- *Support of Turkish Society of Nephrology (earthquake aid):* ERAC responded to the earthquake that struck Turkey in February by supporting dialysis patients who depend on regular treatment. Nearly 1,000 to 8,000 patients in the affected provinces were transferred to surrounding provinces.
- *Support of 3 fellowships (for nephrologists) for the MSc in Clinical Trials (Oxford Population Health):* This initiative consisted of a two-year part-time distance and in person learning course that provided in-depth training in the principles and practice of conducting large-scale, randomised clinical trials. The open call was from October 2, 2023 to January 5, 2024, receiving 7 eligible applications.
- *ERA Neph-Manual:* the aim of this new ERA publication is to promote medical expertise by combining the presentation of interesting case examples with a discussion of pathophysiological mechanisms and therapeutic principles. The manual is exclusively reserved for ERA members and is specifically designed for young nephrologists to support their training and broaden their knowledge in the field of nephrology.





ERA Curatorium (ERAC)

- *Support Direct Relief to Help Ukrainian Patients:* patients on Automated peritoneal dialysis (APD) have lately had an incredibly difficult time given the regular power shortages in many parts of Ukraine. The only way to continue with APD in situations with a limited availability of electricity is to have a powerful battery at your disposal. The Renal Disaster Relief Task Force (RDRTF) has been able to help APD patients.
- *Support of ESPN/ERA registry:* ESPN is the European Society of Paediatric Nephrology. Together with ERA/Registry they are responsible for the Renal Registry which includes paediatric patients on kidney replacement therapy.
- *ERAC Awards 'Innovation in Nephrology in the Age of Digital Revolution':* It aims to recognise excellence in innovation in nephrology by individual ERA members in the field of kidney/renal disease as well as the quality of young talented researchers. It is dedicated to young investigators/researchers who develop new ideas, projects, technologies and services in the field of nephrology that solve specific challenges. This award will be given to young talents who have developed innovative and cutting-edge solutions to a specific problem.

During the 2023 the Ethics Committee worked on the:

- Preparation of scientific articles:
 - ▶ The use of organs of euthanized patients (J. Buturović-Ponikvar).
 - ▶ Ethical issues related with re-transplantation in patients, who lost their first graft due to non-adherence (J. Buturović-Ponikvar).
 - ▶ Ethical issues considering kidney patients during mass disasters (V. Luyckx).
 - ▶ An Ethical lens on Big Data in nephrology (W. Van Biesen): this manuscript was finished at the end of 2023 and will be submitted in early 2024.
- In addition, one article was published:
 - ▶ [Kidney transplantation during mass disasters - from COVID-19 to other catastrophes A Consensus Statement by the DESCARTES Working Group and Ethics Committee of the ERA.](#)
- Participation at the ERA Congresses:
 - ▶ At the 60th ERA Congress Prof. Sever participated as a speaker in the Session "Ethical issue in kidney transplantation" and also chaired the session titled "Armed Conflicts, Kidney Patients and Nephrologists". Furthermore, Prof. Luyckx participated as a speaker in the session "Ethics in Publication (research ethics and good clinical practice)" which was part of a new ERA initiative called "Creatives Labs".

- Participation as member of other ERA Bodies:

- ▶ In 2023, Prof. Luyckx became a member of ERA's new Strong Kidney Task Force which was created to promote awareness for kidney diseases among non-specialists (i.e. family doctors, policy makers, etc.).
- ▶ Since 2022, both Prof. Sever and Prof. Luyckx became members of ERA's Kidney Relief in Disasters Task Force which was created immediately after the invasion of Ukraine to support the nephrology community, and their patients, in Ukraine.
